## **Board discussion on draft MBTA Communities bylaw and Accessory Apartment Bylaw**

- 1. Zoning map change for the MBTA overlay district
- 2. Zoning map change for the inland wetland district boundary based on the currently Soil Conservation Service information for poorly drained soils.
- 3. Two new definitions for Marshfield Affordable Housing Trust and Executive Office of Housing and Living Communities (EOHLC)
- 4. Mixed Use B-1 District change to replace references to Housing Partnership with the Housing Trust and DHCD with EOHLC.

There is now a total of 14 articles for the ATM warrant.

Ms. O'Donnell made a motion to add the additional articles to the ATM warrant. Mr. Monaco seconded it. The vote was Mr. Monaco, Aye; Mr. Pappastratis, Aye; Mr. Cantwell, Aye; and Ms. O'Donnell, Aye.

Mr. Guimond told the Board that the public hearing for the zoning articles will be March 18, 2024. He asked the Board how they would like to hold the public hearing: in-Person, hybrid, or Zoom only. Ms. O'Donnell said that hybrid was not helpful and preferred Zoom only. Mr. Pappastratis agreed that Zoom only was better.
